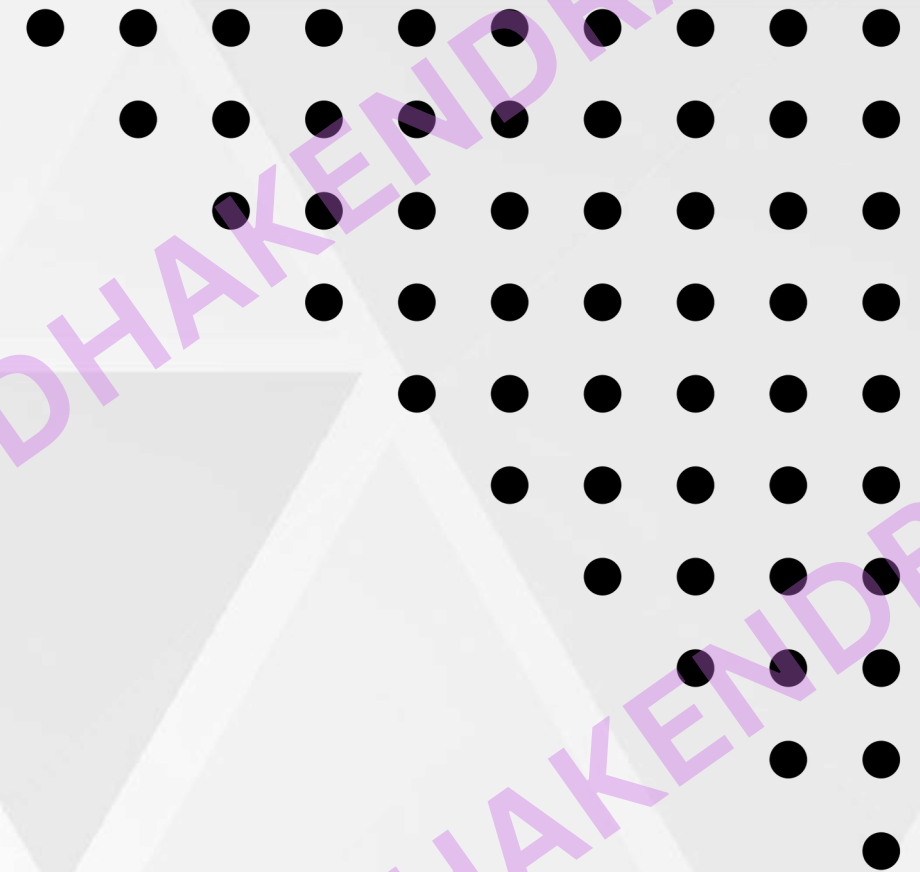

# WHAT IS STARTUP INDIA SCHEME?

Started by Ministry Of Commerce, government of India

- Under the Startup India initiative, eligible companies can get recognized as Startups by DPIIT to access a host of benefits.
- Many enterprising people who dream of starting their own business lack the resources to do so. As a result, their ideas, talent and capabilities remain untapped – and the country loses out on wealth creation, economic growth and employment.
- The Startup India programme allows the businessmen of India to grow their businesses and create wealth and employment.
- Started from 1<sup>st</sup> April 2016.
- **The campaign was first announced by Indian Prime Minister, Narendra Modi during his speech on 15 August 2015.**

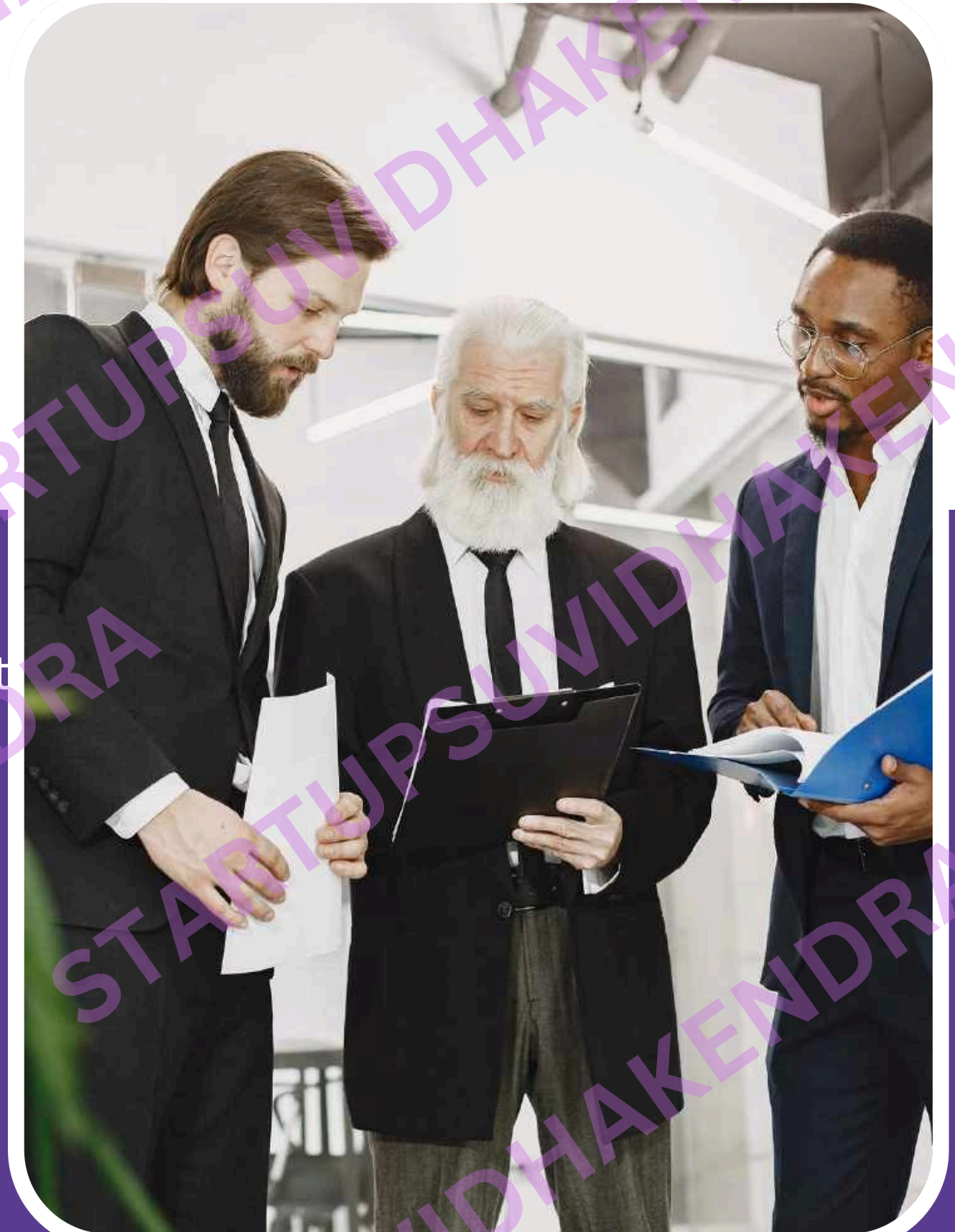

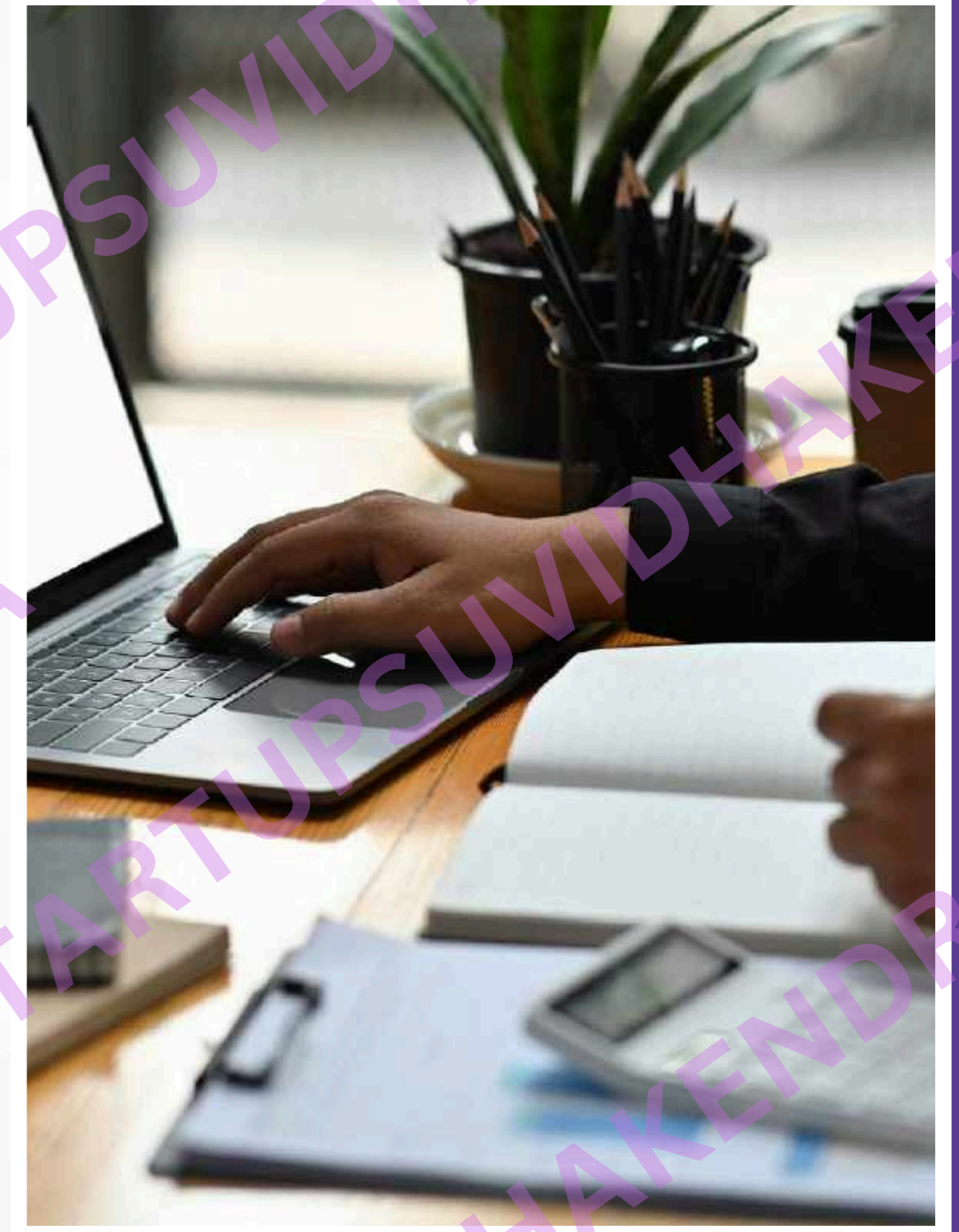

## **SIC ELIGIBILITY CRITERIA**

- Not more than 10 years of incorporation.  
Turnover not exceeding INR 100 crores.
- Incorporated as a Private Limited Company or LLP or Partnership Firm.
- Working towards innovation, development or improvement of products or processes or services, or if it is a scalable business model with a high potential of employment generation or wealth creation.
- Companies like proprietorship, NGO's, Foundation, Social Work related companies are not eligible.
