- **Eligibility**

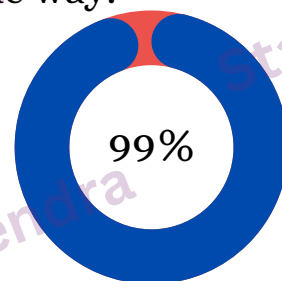
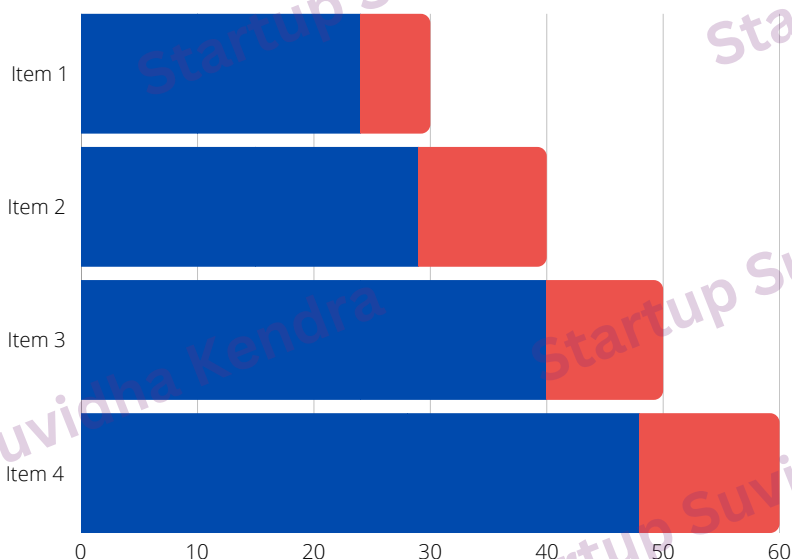
- The startup must be recognized by the Department of Industrial Policy and Promotion (DPIIT).

- The startup must have a business idea that can be commercialized and scaled.



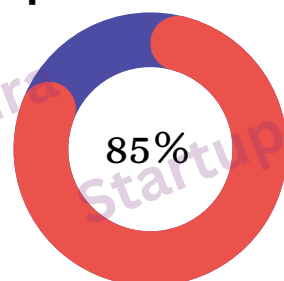
